Wedding Day Logistics - On the wedding day, the hair will be done following a schedule. The Stylist will arrive 15/30 minutes prior to the start time. The Bride must communicate to the bridal party the importance on being on time and properly prepared. Any person getting their hair done in an upstyle, half style, or curls must have their hair already blown dry. Our stylists will not allow time for this. If such a case arises the stylist will charge extra \$50.00 for blow drying if time permits or the original scheduled service will be forfeited and the charge will still apply. The Bride must confirm and commit to the number of services/people stated above. The bride and the stylist will agree on two different styles for hair before the wedding for bridesmaid to choose from. Bridesmaids must communicate which styles they will be getting at time of service. A designated space must be provided to the stylist for set up when on location. The space must consist of the following: Clean area with no walkthrough traffic, chair, adequate lighting and electricity. Extra charges may apply for insufficient space conditions.

Deposit Details - A Non-Refundable Deposit fee of \$100 is required to hold your wedding date. This contract must be accepted 60 days prior to wedding date. Deposit will be applied to the bridal hair the day of.

Trial Run - A trial run is recommended for the bride. The date must be scheduled with your stylist at the salon at least 60 days prior to the wedding date. Any trial date scheduled with less than 30 days will be subject to availability. The actual trial appointment can be up to 1 week prior to wedding date.

Travel Fees - A travel fee of \$25 per stylist will apply for any locations less than 20 miles from salon. Any location greater than 20 miles, an extra charge of \$10 per stylist will apply. Minimum of 3 upstyles or day rate may apply.

Payment - The bride agrees to pay in full on wedding day all services and extra charges that were applied. Payment can be made by cash, or credit card.

Cancellation - This contract can be cancelled 45 days prior to wedding date. Any cancellation occurring after 45 days will result in full charges for all services
